Pre-employment Drug Testing Consent Form

I hereby consent to submit to urinalysis and/or other tests as shall be determined by HPRC in the selection process of applicants for employment for the purpose of determining the drug content thereof.

I agree that the laboratory specified by HPRC may collect these specimens for these tests and may test them or forward them to a testing laboratory for analysis.

I further agree to and hereby authorize the release of the results of said tests to HPRC.

I understand that it is the current use of illegal drugs that prohibits me from being considered for employment at HPRC and not past abuse of alcohol or drugs.

I further agree to hold harmless HPRC and its agents from any liability arising in whole or part out of the collection of specimens, testing, and use of the information from said testing in connection with HPRC's consideration of my application for employment.

I further agree that a reproduced copy of this pre-employment consent and release form shall have the same force and effect as the original.

I understand that if the test results are positive, HPRC will notify me in writing within five working days (24 hours in South Carolina) of the receipt of the positive results. I understand that I have five working days to rebut or explain the positive test. If my explanation is not satisfactory to HPRC at its sole discretion or if I do not respond within five working days of receipt of the results, I will be denied employment at that time. I may initiate another inquiry of employment with HPRC no sooner than six months after the date of the positive test.
